1. Equality Statement (Jaimie, Caitlin, Michael)

Guests: Campus Vision 2050

- a. Context: Campus Vision 2050 is a project under UBC Campus & Community Planning, which is made up of urban planners, architects, and landscape architects. As part of the planning process they have been meeting regularly with Musqueam each 2 weeks over past 2 years.
- b. The online survey is open from Jan 17 Feb 7. They are hosting workshops on February 1,4, 6, & 7. Q: Does the housing action plan include the data from the newly released CMHA report, or will it be updated to reflect this? In previous materials on the Board of Governors site there is a reference to the previous CMHC numbers from 2017.

A: Good question. Check out the Faculty/Staff needs assessment. Today's CMHC data won't be incorporated because we've just seen it. Our question is, what does Faculty/Staff housing cost on campus? To be honest when considering this, it's for comparable housing, i.e. new units. Existing below-market units are currently 60% staff and 40% faculty. This housing doesn't generate profit for UBC. [Housing affordability is a] much bigger regional challenge, it's just really expensive to build rental housing now. We can do 25% below market because the land is free. But will you find rents cheaper than older housing stock? No.

 - **a.** As you know, our local is in the middle of contract negotiations with UBC. We are swimming along and have made a huge amount of progress, I think, in the last little while. You'll hear more from our contract chair Adam later this meeting.

We and UBC both know they are in error. We are getting closer and closer all the time, hoping for complete accuracy soon.

 - i. The grievance committee met most recently on January 17. We tackled all outstanding business. There is no motion on any existing grievances. Partially we are waiting on arbitration / bargaining.

- **d.** Contract Committee (Adam Huizinga)
 - i. As Jaimie mentioned, we've made progress. We had a few meetings that were pretty good in the last few weeks. I wasn't as confident going into the holiday break but now we're feeling optimistic about where things are headed. I can't get into details about certain things, but the rate we're going at now looks fairly good. We have more meetings scheduled in February/March.
 - ii. We circulated a survey re: your experiences on how your departments communicated around snow days. This was incredibly valuable as one of our proposals was around inclement weather/snow policy. We wanted to send the survey partly because we wanted the information for ourselves and partially because we wanted to be able to share this info with UBC. People across campus have very different experiences, from very bad (total lack of communication, told they had to come in, etc.) to good experiences.

Q: Re: federal statutory holidays, as part of bargaining are you going to review the status of the National Day for Truth & Reconciliation as a federal holiday? UBC had not listed it and said they were waiting for the provincial government's decision, but this is a federal holiday.

A: Yes, this was one of our proposals and led to more back and forth than I had expected. One small correction, our CA says we get all provincial AND federal holidays, so we have this day off anyways.

Q: Seeing as talks are going well, can you estimate when we might come to a vote and get everything implemented?

A: Optimistically, I would estimate we could be done around the same timeframe as the last round of bargaining.

Q: Will the final vote take place online?

A: Not sure. There are rules around this, last time we were online due to the pandemic.
