- 5. Business Agent's Report (Ross Idler) most recent grievance #25008 is about returning to work from maternity leave when position has been discontinued. Student Assistants we keep learning of students doing bargaining unit work more than 10 hrs/wk. Student was told could not be put on CUPE contract. Was put on student contract with wrong salary and benefits for 2 months. This is going to be resolved. This file raised a secondary issue of the Student Assistant list being inaccurate. We are due the new list this month. We may need to raise issue elsewhere to get timely info and discuss difference of opinion on what list should include. A simple list of names doesn't help, names/department/hours would be more useful. Workday should be able to pump out reports more often. List arose from a consent order from 30 years ago. Perhaps the parties can agree, if not, arbitrator is seized of this order and can be consulted when disputes arise. 2 accommodations being dealt with, one long term and just returning to work now. HR working hard at finding a suitable position. Supplemental EI benefit for maternity leave.— member was denied because position had a

projected end date in middle of their maternity leave. ER said if they came back after the leave, they could access the SEB retroactively. We take the position that if they come back, they have a position as per Article 30.07 (C)1 and should get the SEB while on leave.
